

# GRANT INVEST

## Terms and Conditions for Awards, Auto Program, Real Estate Program, and MEGA AMBASSADOR Program

Effective date: August 19, 2024

### 1. Eligibility and Participation

1.1. The GRANT INVEST Awards, Auto Program, Real Estate Program, and MEGA AMBASSADOR Program (collectively referred to as "Programs") are open to all active participants in the GRANT INVEST partner program.

1.2. To be eligible for these awards, participants must achieve the specified career statuses as outlined in the GRANT INVEST partner program. These statuses include MANAGER, SR. MANAGER, DIRECTOR, EXECUTIVE DIRECTOR, PRESIDENT, CHAIRMAN, SR. CHAIRMAN, and AMBASSADOR.

### 2. Award Distribution

2.1. The first participants to achieve each career status will receive the corresponding awards as listed below:

- **MANAGER:** iPhone 16
- **SR. MANAGER:** MacBook Air
- **DIRECTOR:** Rolex
- **EXECUTIVE DIRECTOR:** Tesla Model 3
- **PRESIDENT:** Tesla Model Y
- **CHAIRMAN:** Tesla Model X
- **SR. CHAIRMAN:** Studio Apartment in Dubai
- **AMBASSADOR (MEGA AMBASSADOR Program):** Townhouse/Villa in Dubai + 1% of GRANT INVEST's global staking plan revenue for the next 12 months

2.2. These awards will be distributed at the annual GRANT INVEST conference in Dubai.

### 3. Annual Reset and New Calculation

3.1. Starting from January 1st of each year, the award count will reset, and a new calculation will begin for participants who achieve the specified career statuses during the new calendar year.

3.2. Awards are limited in number each year, as follows:

- **MANAGER:** 25 iPhones per year.
- **SR. MANAGER:** 25 MacBook Airs per year.
- **DIRECTOR:** 5 Rolex watches per year.
- **EXECUTIVE DIRECTOR, PRESIDENT, CHAIRMAN:** 5 Tesla vehicles in total per year.
- **SR. CHAIRMAN:** 4 studio apartments per year.
- **AMBASSADOR (MEGA AMBASSADOR Program):** 2 Townhouses/Villas per year, maximum of 2 participants for the 1% revenue bonus.

#### **4. MEGA AMBASSADOR Program**

4.1. The MEGA AMBASSADOR Program is an exclusive component of the AMBASSADOR status and is available to a maximum of 2 partners per year.

4.2. This program is activated immediately upon achieving the AMBASSADOR status and is valid for 12 months.

4.3. MEGA AMBASSADOR participants will receive 1% of GRANT INVEST's global staking plan revenue for the next 12 months following their status achievement. This bonus is paid out in a lump sum at the end of the next tax year.

4.4. The bonus is only available to partners who maintain an active ULTIMATE PLAN staking plan during the current and following year after activation.

#### **5. Award Conditions**

5.1. Awards are non-transferable and cannot be exchanged for cash or other items, except at the discretion of GRANT INVEST.

5.2. In the event that a participant achieves a status after the annual award limit has been reached, they will be eligible to receive the award in the following year, subject to availability.

#### **6. Notification and Acceptance**

6.1. Winners of the awards will be notified via the contact information provided in their GRANT INVEST account. If a winner cannot be contacted or fails to accept the award within the specified timeframe, GRANT INVEST reserves the right to offer the award to another eligible participant.

6.2. Participants must attend the annual conference in Dubai to receive their awards unless otherwise arranged with GRANT INVEST.

#### **7. Additional Conditions**

7.1. GRANT INVEST reserves the right to modify, suspend, or terminate the Programs at any time without prior notice.

7.2. GRANT INVEST is not responsible for any taxes or additional costs associated with claiming or using the awards.

7.3. By participating in the Programs, participants agree to these Terms and Conditions.

#### **8. Governing Law**

8.1. These Terms and Conditions are governed by the laws of the jurisdiction in which GRANT INVEST is located, without regard to its conflict of law provisions.
